ISO STANDARDS UPDATE: DRAFT REVISIONS & WHAT'S NEXT

Work on revising ISO's core management system standards is moving forward. A second draft of ISO 9001 was released in September 2024, with updates expected to strengthen resilience, supply chain management, and sustainability. Publication is expected in September 2026. ISO 14001 has reached the Final Draft stage, while ISO 45001 is set for further review in 2025.
